

ADVERSE REACTION

- **DO NOT** use the device if you are pregnant, planning to become pregnant, or breastfeeding. The device has NOT been tested on pregnant or breast-feeding women and therefore the risk to the fetus, neonate or pregnant women is unknown.
- DO NOT use the device if you are under the age of 18.
- DO NOT use the device over areas with phlebitis, thrombophlebitis, and varicose veins.
- DO NOT use the device if you have a known allergic reaction to aluminum, silicone or plastics. The device contains plastics, silicone and metals that come into contact with the skin during

use. When in doubt of allergies, contact your health professional before using the device.

- **DO NOT** use the device if you suffer from any photosensitive disorder (sensitization to light) or genetic conditions of the eye.
- DO NOT use the device if you suffer from any serious skin condition such as severe
 acne.
- DO NOT use the device if you are taking any medication or drugs that can cause photosensitivity. If you are not sure about your medication, contact your health professional.
- DO NOT use the device if you suffer from light-induced headaches.
- DO NOT use the device if you have a medical history of seizures or epilepsy triggered by light.
- DO NOT use the device on the eyes or very close to the eye area.
- DO NOT continuously press the ON/OFF button.

Note: We highly suggest being cautious when taking any (skin-related) medications. If in doubt, consult your health professional.

Note: If you are under the care of a physician, consult them before using this device

WARNINGS

- STOP using the device and consult your health professional if you experience an adverse reaction from using the device.
- STOP using the device if you experience any discomfort or difficulty breathing or swallowing occurring from application of the device on the neck.
- STOP using the device if you experience symptoms of hypotension (dizziness or light-headedness) while using the device.
- STOP using the device if it is overheating. Turn it off immediately.
- STOP your treatment if it feels hot or your skin feels uncomfortably warm.
- DO NOT let children play with the device. Cleaning and charging the device shall not be done by children.
- **DO NOT** use the device to treat rosacea, moles, warts, open sores, cancerous lesions, or any skin condition.
- **DO NOT** use the device on spots without pigmentation or areas on the skin that have vitiligo.
- **DO NOT** shine the light from the LEDs directly into your eyes or someone else's eyes. This may cause temporary loss of sight.
- DO NOT place the device on any open wounds.
- DO NOT use the device outdoors to prevent damage to the product.
- DO NOT sit, lay down on, or step on the device. This will break the device.
- DO NOT drop or insert any object into any openings on the device.
- DO NOT use the device if it is not working properly, or if it has been dropped or damaged. For warranty and repairs, contact customer support.

- DO NOT use or store the device near hot surfaces.
- DO NOT charge the device when it is close to or might come into contact with water.
- DO NOT submerge the device in water.
- DO NOT store the device in extreme heat or cold.
- . DO NOT place the device in direct sunlight.

- **DO NOT** use the device over areas of skin that lack normal sensation. Only use the device on normal, intact, clean, and healthy skin.
- DO NOT use the device while driving, operating machinery, or during an activity in which voluntary muscle contractions may put users or the public at any risk of injury.
- DO NOT use the device on swollen, infected, or inflamed areas or skin eruptions.
- **DO NOT** use the device in the eye area (i.e. eyeball, circular muscle within the orbital rim), on the temples, the breast, or groin area.
- DO NOT apply excessive pressure when using the device on the anterior neck.
- DO NOT use the device in high humidity locations such as the shower or sauna.
- **DO NOT** exceed the recommended treatment time of 3 minutes per treatment area when using the device.
- If there has been sunburn on your skin in the past two weeks, it is recommended not to use this product.
- This device is intended to be used by one person, we recommend to avoid sharing with others.

Note: The device should only be supplied with 5V DC low voltage. If any part of the main adapter or cable is damaged, discontinue use. Contact Solawave customer support to arrange a cable replacement.

PRECAUTIONS

Do not scratch or damage the light-emitting surface.

- Not operating the device in accordance with the instructions in the manual will void vour warranty.
- Read all instructions carefully before using this device.
- Store the device according to the protocol outlined in this manual.
- This device is intended to be used by one person only.
- The device is designed for cosmetic use only, for individuals with good health. Please contact your health professional if you are unsure about your health status.
- The device's battery is not removable. If you are disposing of the device, do not burn it or throw it in the trash. Dispose of the device according to local regulations.
- Inspect the device and do not use it if you see any signs of damage, such as internal battery leaks. If anything seems out of the ordinary, contact our customer support.
- The device should only be supplied with 5V DC low voltage. If any part of the main adapter or cord is damaged, discontinue use. Contact customer support to arrange a replacement.
- Consult your health professional before using the device if you have a fever, acute inflammation, a severe circulatory disorder, light sensitivity, anesthetic, or desensitized areas.
- We highly suggest using caution if you are taking any medications. If in doubt, consult your health professional.

- Some users may experience skin irritation or hypersensitivity due to the electrical stimulation or the topical product applied.
- Skin irritation and burns beneath the electrodes have been reported with the use
 of other powered muscle stimulators. If you experience skin irritation or burning,

discontinue use immediately. If using the device causes persistent pain or discomfort, discontinue use immediately.

- A slight tingling sensation may occur while using the device.
- There may be a perception of flashing lights during the use of the device, resulting from the stimulation of your optic nerve. If you notice this condition constantly without the use of your device, consult your health professional.
- Once the device is turned on it is intended for immediate use. Only turn on the device when it is in contact with your skin otherwise the device may become hot. Do not shine into your eyes.

TRAVEL AND INTERNATIONAL USE

The device's lightweight design makes it a perfect travel companion. Here are some travel tips:

- If you are traveling to a different region to where you bought the device, please ensure that the device is only supplied with a 5V DC low voltage.
- Prior to your flight, confirm with a steward that the device can be carried and/or used on the airplane.

POTENTIAL RISKS

- Immediately after treatment, skin may appear red. Skin should return to normal within 1–2 hours.
- Temporary headaches may develop immediately following the light treatment.
 Headaches can be treated with an appropriate pain killer and rehydration.

POTENTIAL BENEFITS

- Red Light Therapy: Improves the skin wellness and makes your skin feel young.
- \bullet Infrared Light Therapy: Relaxes the muscles and reduces tension in the body.

 Therapeutic Warmth: warming the skin can temporarily relieve skin fatigue and lead to a beautiful, healthy glow.

LIGHT SENSITIVITY TEST

We highly recommend users perform a light sensitivity test before their first use of the device

- 1. Place the device on the inner forearm.
- Turn on the device to start a treatment.
- Move the device in slow, gentle motions for up to 3 minutes per area.
- 4. Wait until the treatment is done. The full treatment will take 12 minutes to complete.
- 5. If your skin feels hot or uncomfortable during the treatment, stop immediately! You might be sensitive to light.
- 6. The device will automatically turn off after the treatment is done. Remove the device and wait for at least 24 hours before your next treatment.

Check your skin regularly over those 24 hours. If your skin appears red and/or itchy, the device is unsuitable for you. In case of sensitivity to the light, please contact customer support.

HOW TO USE THE DEVICE

GENERAL USE

- 1. Prior to using the device, make sure it is fully charged and unplugged.
- 1. Prior to using the device, make sure it is fully charged and unplugged.
- 2. Cleanse the area that you want to treat.
- 3. Pop out the grip and slide it between two fingers
- 4. Turn on the device and enjoy the treatment.
- a. Hold the ON/OFF button until the lights turn on (about 2 seconds) to turn on the device. You will see the lights turn on and the device will begin to warm up.
- b. Move the device in slow, gentle motions for up to 3 minutes per area. The device will blink, signaling you to move to a different treatment area. The device can be used anywhere treatment is needed on the face, neck, or body.
- c. The device switches off automatically after a 12-minute treatment. You may stop the treatment at any time and turn off the device by holding the ON/OFF button for 2 seconds.
- 5. Take the device off the treatment area.
- 6. You may clean the device using a water-based wipe or a 70% alcohol wipe. Ensure the device is not connected to the power supply when cleaning. Do not submerge the device in water or apply water directly to the device.
- 7. Repeat these steps based upon the treatment protocol described in the next section.

TREATMENT PROTOCOL

Use the device 12 minutes per day, 3 days per week for a minimum of 4 weeks. After that, you can continue using the device as desired.

Always be mindful of how your skin reacts to beauty devices, and decrease usage if redness or irritation occur.

CHARGING

Charge your device fully up to 2 hours before your first use. Only use a 5V adapter or USB port (avoid fast chargers as they can damage the battery).

To charge the device, attach the charger to the device. Insert the USB-A side of the cable into a USB power supply. The LED indicator on the device will start to blink to indicate charging. When the device is fully charged, the LED indicator will stay on.

If the LED indicator remains on when you first connect the charging cable, then your device is already fully charged and you may begin using. If the light is blinking please charge until the light remains steady.

Before charging, make sure that the plug and socket are completely dry. Failure to do so may result in electric shock, short circuit, or fire.

Note: Always unplug the device before use. The device will not work while being charged.

TROUBLESHOOTING

If the following suggestions do not fix the problem or the problem reoccurs, and your device is within the warranty period, please return it to Solawave.

- . DO NOT attempt to investigate any further.
- **DO NOT** attempt to modify the device in any way. The device has NO parts you can repair yourself.

CARE AND STORAGE

The lifetime of the lithium battery can be maximized by allowing it to fully charge and discharge during regular use. Allow the device to deplete before charging again. Do not charge after every session.

- Store the device at room temperature in dry conditions.
- Store the device in the supplied bag. Make sure the device will not bend, stretch, or be crushed while being stored or when traveling.
- Avoid storing the device in dusty conditions, direct sunlight, or damp and humid conditions.
- This device contains no serviceable parts.
- Before each use, ensure the device is switched off and clean it, following the cleaning instructions below.

IMPORTANT

- The device may remain hot after hot therapy. Let the device cool down before storing.
- The product has a limited lifecycle of two years under nominal use. Following the treatment protocol for two years is considered nominal use.
- The device must be handled with care.

CLEANING

- Clean the device with a water-based wipe or damp clean cloth. Stubborn stains can be removed by wiping gently with a 70% alcohol wipe.
- DO NOT use any other cleansing devices as these may damage the device.
